The University of Michigan Press has partnered with LYRASIS to develop a model that works toward a more sustainable, open future while also inspiring other nonprofit publishers to do the same.




Fund to Mission: The Press's Open Access Monograph Model

The Press is transitioning to an OA monograph model termed "Fund to Mission." Fund to Mission demonstrates a return to the origins of the university press movement and moves toward a more sustainable infrastructure for the humanities and social sciences.

With this model, the Press aims to convert at least 75% of its monographs to open access by the end of 2023, without any author ever having to pay. The Press is working to build a sustainable model by achieving stable funding for this monograph program from three sources: annual funding from the library community, additional recurring funds from U-M, and other funder payments. To date, we have the support of several libraries and consortia and look to continue expanding our community of supporters. You can read more about this model on page 38 of the catalog.

The Press is excited by the emerging energy and opportunities around open access. We are committed to furthering our mission and to be transparent about our transition to an open publishing program. We encourage you to follow our journey at <u>press.umich.edu/librarians</u>.



Made-Up Asians

Yellowface During the Exclusion Era Esther Kim Lee

Explores the history of misrepresentations of Asian characters on stage and screen

Made-Up Asians traces the history of yellowface, the theatrical convention of non-Asian actors putting on makeup and costume to look East Asian. Using specific case studies from European and U.S. theater, race science, and early film, Esther Kim Lee traces the development of yellowface in the U.S. context during the Exclusion Era (1862–1940), when Asians faced legal and cultural exclusion from immigration and citizenship. These caricatured, distorted, and misrepresented versions of Asians took the place of excluded Asians on theatrical stages and cinema screens. The book examines a wide-ranging set of primary sources, including makeup guidebooks, play catalogs, advertisements, biographies, and backstage anecdotes, providing new ways of understanding and categorizing yellowface as theatrical practice and historical subject. *Made-Up Asians* also shows how lingering effects of Asian exclusionary laws can still be seen in yellowface performances, casting practices, and anti-Asian violence into the 21st century.

Queer Voices in Hip Hop

Cultures, Communities, and Contemporary Performance Lauron J. Kehrer

Positions queer and trans hip hop within the longer tradition of Black queer music


Notions of hip hop authenticity, as expressed both within hip hop communities and in the larger American culture, rely on the construction of the rapper as a Black, masculine, heterosexual, cisgender man who enacts a narrative of struggle and success. In *Queer Voices in Hip Hop*, Lauron J. Kehrer turns our attention to openly queer and trans rappers and positions them within a longer Black queer musical lineage. Combining musical, textual, and visual analysis with reception history, this book reclaims queer involvement in hip hop by tracing the genre's beginnings within Black and Latinx queer music-making practices and spaces, demonstrating that queer and trans rappers draw on Ballroom and other cultural expressions particular to queer and trans communities of color in order to articulate their subject positions. By centering the performances of openly queer and trans artists of color, *Queer Voices in Hip Hop* reclaims their work as essential to the development and persistence of hip hop in the United States as it tells the story of the queer roots of hip hop.



The lived experiences of African students in communist East Germany

This book explores the largely unexamined history of Africans who lived, studied, and worked in the German Democratic Republic. African students started coming to the East in 1951 as invited guests who were offered scholarships by the East German government to prepare them for primarily technical and scientific careers once they returned home to their own countries. Drawn from previously unexplored archives, *African Students in East Germany, 1949–1975* uncovers individual stories and reconstructs the pathways that African students took in their journeys to the GDR and what happened once they got there.



Marginal People in Deviant Places

Ethnography, Difference, and the Challenge to Scientific Racism Janice M. Irvine

How twentieth-century ethnographers captured the diverse social worlds of outsiders

Marginal People in Deviant Places revisits early- to mid-twentieth-century ethnographic studies, arguing that their focus on marginal subcultures ranging from American hobos, to men who have sex with other men in St. Louis bathrooms, to hippies, to taxi dancers in Chicago, to elderly Jews in Venice, California—helped produce new ways of thinking about social difference more broadly in the United States. Irvine demonstrates how the social scientists who told the stories of these marginalized groups represented an early challenge to then-dominant narratives of scientific racism, prefiguring the academic fields of gender, ethnic, sexuality, and queer studies in key ways. In recounting the social histories of certain American outsiders, Irvine identifies an American paradox by which social differences are both despised and desired, and she describes the rise of an outsider capitalism that integrates difference into American society by marketing it.



Tales of Dionysus is the first English verse translation of one of the most extraordinary poems of the Greek literary tradition, the *Dionysiaca* of Nonnus of Panopolis. By any standard, the *Dionysiaca* is a formidable work. It is by far the longest poem surviving from the classical world, a massive mythological epic stretching to over 20,000 lines, written in the tradition of Homer, using Homer's verse, Homer's language, his narrative turns and motifs, and invoking his ancient Muses. But it is also the *last* ancient epic to follow a Homeric model, composed so late in fact that it stands as close in time to the Renaissance as it does to archaic Greece. Out of its formal epic frame spills a tumult of ancient literary types: tragedy, elegy, didactic, panegyric, pastoral idyll, and the novel are all parts of this gigantic enterprise, each genre coming to the fore one after the other.

William Levitan is Professor of Classics Emeritus at Grand Valley State University. **Stanley Lombardo** is Professor Emeritus of Classics at The University of Kansas.






How states determine the role of the Second Amendment

The U.S. Supreme Court increasingly matters in American political life. People across the political spectrum look to the Court for relief from policies they oppose, while simultaneously hoping the Court will advance the policy agendas they believe in. However, the Court and the courts are, in reality, more of a sideshow to the culture war than stars of its center ring. While court decisions, especially Supreme Court decisions, are important, the decisions emanating from the Court reflect social, cultural, and political change that occurred long before the judges' ruling. Courts are not powerless institutions. But reformers will not have success in the courts unless supported by the elected branches and by public opinion. In this insightful book that examines the relationship between state power and the Second Amendment, Anthony D. Cooling argues specifically that preexisting state culture is a key factor in the power that courts have to influence laws.



Environmental violence and recovery in transpacific cultural expressions

Empire and Environment argues that histories of imperialism, colonialism, militarism, and global capitalism are integral to understanding environmental violence in the transpacific region. The collection draws its rationale from the imbrication of imperialism and global environmental crisis, but its inspiration from the ecological work of activists, artists, and intellectuals across the transpacific region. Taking a postcolonial, ecocritical approach to confronting ecological ruin in an age of ecological crises and environmental catastrophes on a global scale, the collection demonstrates how Asian North American, Asian diasporic, and Indigenous Pacific Island cultural expressions critique a de-historicized sense of place, attachment, and belonging.

Jeffrey Santa Ana is Associate Professor of English at Stony Brook University. Heidi Amin-Hong is Assistant Professor of English at University of California, Santa Barbara. Rina Garcia Chua is a Jack and Doris Shadbolt Fellow in the Humanities at Simon Fraser University. Zhou Xiaojing is Professor of English at the University of the Pacific.

The Korean War and Korean American Life Writings Stephen Hong Sohn

Forgotten archives and life writings of Korean War refugees

The Korean War, often invoked in American culture as "the forgotten war," remains ongoing. Though active fighting only occurred between 1950 and 1953, the signing of an armistice resulted in an infamous stalemate and the construction of the Korean Peninsula's Demilitarized Zone. *Minor Salvage* reads early Korean American life writings in order to explore the admittedly partial ways in which those made precarious by war seek to rebuild their lives.



Dr. Hu Shih (1891–1962) was one of China's top scholars and diplomats and served as the Republic of China's ambassador to the United States during World War II. In the 1950s, Hu Shih started to analyze the development and nature of Communism, delivering a series of lectures and addresses to reveal what he called Stalin's "grand strategy" for facilitating the International Communist Movement. This volume brings together a collection of Hu Shih's most important, English-language speeches, interviews, and commentaries on international politics, and China-U.S. relations.

Using an array of novel archival, documentary, and quantitative historical data, this book illustrates that China's land reform campaign in the early 1950s was not just about economic redistribution but rather part of a larger, brutally violent state-building effort to delegitimize the new party-state's internal rivals and establish its moral authority.

While the loss of sight—whether in early modern Japan or now—may be understood as a disability, blind people in the Tokugawa period (1600–1868) could thrive because of disability. The blind of the era were prominent across a wide range of professions, and through a strong guild structure were able to exert contractual monopolies over certain trades. *Blind in Early Modern Japan* illustrates the breadth and depth of those occupations, the power and respect that accrued to the guild members, and the lasting legacy of the Tokugawa guilds into the current moment.



How Jews and Turks impacted influential reformer Andreas Osiander

Lutheran preacher and theologian Andreas Osiander (1498–1552) played a critical role in spreading the Lutheran Reformation in sixteenth-century Nuremberg. *The Apocalypse in Reformation Nuremberg: Jews and Turks in Andreas Osiander's World* is the first book in any language to concentrate on his attitudes toward both Jews and Turks, and it presents the first published English translation of Osiander's famous treatise in defense of Jews against blood libel. Osiander's writings on Jews and Turks also provide a valuable mirror to reflect on the historical antecedents to modern antisemitism and Islamophobia and thus elucidate how the related stereotypes and prejudices are both perpetuated and overcome.

Interest Representation in Mexico Brian Palmer-Rubin

Patronage as ruination for small farms and businesses

Why have Latin American democracies proven unable to confront structural inequalities? Brian Palmer-Rubin contends that we may lay the blame on these countries' systems of interest representation, which exhibit "biased pluralism," a system in which the demands of organizations representing economic elites predominate. A more inclusive model of representation would require a more encompassing and empowered set of institutions to represent workers, and would also feature spaces for nonelite producers such as farmers and small-business owners to have a say in sectoral economic policies.



Analyzing the visual syntax and display rhetoric applied in newspaper photos, national historical albums, and museum exhibitions, Noa Hazan shows that although racial thought was and still is verbally suppressed in Israel, it is vividly present in its nonverbal official and public visual sphere. In the Israeli case, the behavior and manners of Mizrahim were understood as an outcome of the primitive Arab cultures they grow up in. Engraved in their body, these cultural traits were depicted and understood as racialbiological qualities and were visually manipulated to silo Ashkenazim and Mizrahim in Israel as distinct racial types.

This monograph of Muslim life focuses on young male migrants of rural origin who move to build better lives in Bougouni, a provincial town in southwest Mali. Describing themselves as "simply Muslims" and "adventurers," these migrants aim to be both prosperous and good Muslims. Drawing on seventeen months of fieldwork, author André Chappatte explores their sense of prosperity and piety in what they call "tunga" (adventure), a customary search for money and more dating from the colonial period.





Disputed truths surrounding land in Africa and beyond

In *Power/Knowledge/Land*, author Laura German profiles the consolidation of a global knowledge regime surrounding land and its governance within international development circles following the outcry over "global land grabs," and the growing enrollment of previously antagonistic actors within it. Drawing theoretical insights from ontological anthropology and decolonial theory and deploying pioneering analytical techniques inspired by the politics of knowledge, German reveals the inner mechanics of a global knowledge regime that has enabled the longstanding project of commodifying customary land to be advanced by capturing the energies of socially progressive forces.

The shift from human decision-making in security services to AI

Much of the South African government's response to crime—especially in Johannesburg—has been to rely increasingly on technology. This includes the widespread use of video cameras, Artificial Intelligence, machinelearning, and automated systems, effectively replacing human watchers with machine watchers. The aggregate effect of such steps is to determine who is, and isn't, allowed to be in public spaces—essentially another way to continue segregation. These new software-based surveillance technologies represent monitoring, tracking, and information gathering without walls, towers, or guards.



A bottom-up analysis of what displaced people need

Growing numbers of people are displaced by war and violent conflict. In Afghanistan, Ethiopia, Myanmar, Syria, and elsewhere violence pushes civilian populations from their homes and sometimes from their countries. In previous decades, millions of displaced people returned to their place of origin after conflict or were resettled in countries in the Global North. Now displacements last longer, the number of people returning home is lower, and opportunities for resettlement are shrinking.

Using case studies and first-person accounts from interviews and fieldwork in post-conflict settings such as Uganda, Liberia, and Kosovo, Sandra F. Joireman highlights the divergence between these policies and the preferences of conflict-displaced people. Rather than looking from the top down, at the rights that people have in international and domestic law, the perspective of this text is from the ground up—examining individual and household choices after conflict.

Proceeding from these beginnings, *Méliès Boots* traces how the full trajectory of Georges Méliès' career during the late-nineteenth and early-twentieth centuries, along with the larger cultural and historical contexts in which Méliès operated, shaped his cinematic oeuvre. By positioning Méliès in relation to the material culture of his time, Solomon demonstrates that Méliès' work was expressive of a distinctly modern, and modernist, sensibility that appeared in France during the 1880s in the wake of the Second Industrial Revolution.

Contingent Encounters

Improvisation in Music and Everyday Life Dan DiPiero

The relationship between improvisation in music and in everyday life

Contingent Encounters offers a sustained comparative study of improvisation as it appears between music and everyday life. Drawing on work in musicology, cultural studies, and critical improvisation studies, as well as his own performing experience, Dan DiPiero argues that comparing improvisation across domains calls into question how improvisation is typically recognized. By comparing the music of Eric Dolphy, Norwegian free improvisers, Mr. K, and the Ingrid Laubrock/Kris Davis duo with improvised activities in everyday life (such as walking, baking, working, and listening), DiPiero concludes that improvisation appears as a function of any encounter between subjects, objects, and environments. Taking seriously the claim that improvisation is the same thing as living, Contingent Encounters overturns long-standing assumptions about the aesthetic and political implications of this notoriously slippery term.






The Greco-Egyptian Magical Formularies


In Greco-Roman Egypt, recipes for magical undertakings, called magical formularies, commonly existed for love potions, curses, and attempts to best business rivals. In The Greco-Egyptian Magical Formularies: Libraries, Books, and Individual Recipes, volume editors Christopher Faraone and Sofía Torallas Tovar present a series of essays by scholars involved in a multiyear project to reedit and translate magical handbooks that were inscribed in the Roman period in the Greek or Egyptian languages. For the first time, the material remains of these papyrus rolls and codices are closely examined, revealing important information about the production of books in Egypt, their scribal culture, and the traffic in single recipes copied from them. Especially important are new insights in the historical shift from roll to codex, complicated methods of inscribing the bilingual texts, and the new realization that several of the longest handbooks are clearly compilations of shorter handbooks. The essays also reexamine the idea that these handbooks came from the personal libraries of practicing magicians or temple scriptoria, in one case suggesting that two of the handbooks had literary pretensions of a sort and were designed to be read for pleasure.




It is generally accepted that Roman administrators, reaching Egypt in the aftermath of Augustus' annexation, confiscated the land and other property owned by Egyptian temples. It is further accepted that this confiscation doomed the temples by removing their economic support and making them subservient to the Roman state, and that this then led to the collapse of Egyptian religion. In his new monograph, Andrew Connor takes issue with both claims. Connor offers a fundamentally revised interpretation of the key documents, relating these events and exploring these papyri through their historical, intellectual, and linguistic contexts, alongside a number of other important texts bearing on the relationship between the temples and the Roman state.



Africa in Translation provides a strong and thoughtful study of *Afrikanistik's* role in the construction of racialist knowledge in Germany.

Sara Pugach is Professor of History at California State University, Los Angeles.

Pugach argues that Afrikanistik was essential to the construction of racialist knowledge in Germany. While in other countries biological explanations of African difference were central to African studies, the German approach was essentially linguistic, linking language to culture and national identity. Africa in Translation follows the history of Afrikanistik from its roots in the missionaries' practical linguistic concerns to its development as an academic subject in both Germany and South Africa throughout the nineteenth and twentieth centuries.


Reading the Aeneid as the central text of Roman literary education, Yasmin Syed investigates the poem's power to shape Roman notions of self and cultural identity

Yasmin Syed is Lecturer in the Department of Classics at the University of California, Berkeley.

Through an explortion of the Aneid, Syed analyzes Roman pedagogy and reading practices as well as ancient beliefs about the powerful influence of poetry. Her study considers these cultural components together with the aspects of identity that define the Aeneid's characters. By doing so, Syed shows how Vergil's ancient audiences saw themselves—their experiences, goals, and values—reflected in the poem and guided by it.

Rouge River Revived *How People Are Bringing Their River Back to Life* Edited by John H. Hartig and Jim Graham Foreword by William Clay Ford, Jr.

The Rouge River is a mostly urbanized watershed of about 500 square miles populated by nearly 1.4 million people. While not geographically large, the river has played an outsized role in the history of southeast Michigan, most famously housing Ford's massive Rouge Factory, designed by architect Albert Kahn and later memorialized in Diego Rivera's renowned "Detroit Industry" murals. In recent decades, the story of the Rouge River has also been one of grassroots environmental activism. After pollution from the Ford complex and neighboring factories literally caused the river to catch on fire in 1969, community groups launched a Herculean effort to restore and protect the watershed. Today the Rouge stands as one of the most successful examples of urban river revival in the country.

Rouge River Revived describes the river's history from pre-European times into the 21st century. Chapters cover topics such as Native American life on the Rouge; indigenous flora and fauna over time; the river's role in the founding of local cities; its key involvement in Detroit's urban development and intensive industrialization; and the dramatic clean-up arising from citizen concern and activism. This book is not only a history of the environment of the Rouge River, but also of the complex and evolving relationship between humans and natural spaces.

John Hartig serves as a Visiting Scholar at the University of Windsor's Great Lakes Institute for Environmental Research, as the Great Lakes Science-Policy Advisor to the International Association for Great Lakes Research, and as a member of the Board of Directors of the Detroit Riverfront Conservancy.

Jim Graham is an award-winning journalist for the *Detroit News* and the former Executive Director of Friends of the Rouge.
