Lowell W. Barrington is associate professor of political science at Marquette University. He received his Ph.D. from the University of Michigan. His specializations include postcommunist politics, citizenship, ethnicity and nationalism, and comparative democratization. His publications include articles on postcommunist citizenship and ethnicity issues in *World Politics*, *Post-Soviet Affairs*, *Europe-Asia Studies*, the *European Journal of Political Research*, *Nationalities Papers*, the *Review of Central and East European Law*, *Post-Soviet Geography and Economics*, and *PS: Political Science and Politics*. He is also the author of book chapters in *From Migrants to Citizens: Membership in a Changing World* (2000) and *Dilemmas of State-Led Nation Building in Ukraine* (2002). He is currently working on a book manuscript titled *Comparative Politics: Structures and Choices*.

Ian Bremmer is president of Eurasia Group and Senior Fellow at the World Policy Institute. He received his Ph.D. in political science from Stanford University and has held positions at the Harriman Institute, Hoover Institution, the EastWest Institute, and Lawrence Livermore National Laboratory. He is a columnist for the *Financial Times* and commentator on *CNN*, *FOXNews*, and *CNBC*. An expert on U.S. foreign policy, Eurasian states in transition, and global political risk, he has published widely on nation- and state-building and international relations in global emerging markets. His publications include *New States, New Politics: Building the Post Soviet Nations* (1997) and articles and essays in *International Affairs*, *National Interest*, the *World Policy Journal*, the *Journal of Democracy*, *New Republic*, the *Los Angeles Times*, the *Wall Street Journal*, the *International Herald Tribune*, and the *New York Times*.

John F. Clark is associate professor of international relations at Florida International University in Miami. He received his Ph.D. from the University of Virginia. He has carried out research in Congo-Brazzaville (1990, 1997) and Congo-Kinshasa (1994). In 1999–2000, he was a Fulbright scholar at Makerere University, Kampala (Uganda). He is coeditor of *Political Reform in Francophone Africa* and has published in the *Journal of Democracy*, *Studies in Comparative International Development*, the *Journal of Modern African Studies*, *Africa Today*, and *Current History*.

Terry D. Clark is professor of political science and director of the graduate program in international relations at Creighton University. He received his Ph.D. from the University of Illinois at Urbana-Champaign. He has published widely on democratic institutional development in the postcommunist states. His work has appeared in *Comparative Political Studies*, *Slavic Studies*, *East European Politics and Societies*, and *Nationalities Papers*. He has authored two books, including *Beyond Post-Communist Studies: Political Science and the New Democracies of Europe* (2002).

Joshua B. Forrest is the Director of the Kerr Institute of African History, Politics and Culture at La Roche College, Pittsburgh. He received his Ph.D. from the University of Wisconsin–Madison. His latest books are *Subnationalism in Africa: Ethnicity, Alliances, and Politics* (2004) and *Lineages of State Fragility: Rural Civil Society in Guinea-Bissau* (2003). He has also published a number of book chapters and articles concerning ethnic politics, democracy building, the African “inverted” state, and comparisons with medieval European states. His work has appeared in the *Journal of Commonwealth and Comparative Politics*, the *Journal of Democracy*, the *World Policy Journal*, *Comparative Politics*, *Studies in International Comparative Development*, and the *Journal of Modern African Studies*.

Stephen Jones is professor of Russian and Eurasian studies at Mount Holyoke College. He received his Ph.D. from the London School of Economics and Political Science. He has taught at the University of California, University of London, and Oxford University. In 2001, he conducted research in Georgia under an IREX grant and was a member of the Institute for Advanced Study in Princeton. He has written over fifty articles and chapters on current events in the former Soviet republic of Georgia and is

currently completing the second volume of his *Georgian Social Democracy: In Opposition and Power*. The first volume is *Socialism in Georgian Colors: The European Road to Social Democracy, 1883–1917* (2005).

Taras Kuzio is a visiting professor at the Elliott School of International Affairs, George Washington University. He is a former Resident Fellow, Centre for Russian and East European Studies, University of Toronto; director of the NATO Information Office in Kyiv; and Senior Research Fellow at the Centre for Russian and East European Studies of the University of Birmingham. He has published widely in political science and area studies journals on nationalism, transition and democratization, and Ukrainian and postcommunist affairs. His books include *Ukraine: Perestroika to Independence* (2000), *Ukraine: State and Nation Building* (1998), *Ukraine under Kuchma* (1997), *Ukrainian Security Policy* (1995), and the edited collection *Contemporary Ukraine* (1998). He has also jointly authored *Politics and Society in Ukraine* (1999) and jointly edited *Dilemmas of State-Led Nation Building in Ukraine* (2002), *Ukrainian Foreign and Security Policy: Theoretical and Comparative Perspectives* (2002), and *State and Institution Building in Ukraine* (1999).

Diane K. Mauzy is professor of political science at the University of British Columbia (Vancouver), where she also received her Ph.D. She specializes in the politics of Southeast Asia, particularly Malaysia, Singapore, and Indonesia. She is the author of about forty books and articles. Her latest books (coauthored) are *Malaysian Politics under Mahathir* (1999) and *Singapore Politics under the People's Action Party* (2002), and her recent articles have appeared in *Pacific Review* and *Round Table*.

Razmik Panossian is the Director of Programmes at Rights and Democracy. He taught nationalism and post-Soviet transition/democratization at the Department of Government, London School of Economics and Political Science (LSE), where he received his Ph.D. His dissertation on Armenian nationalism and diaspora won the Lord Bryce Prize for Best Dissertation in Comparative and International Politics in the UK. He has published numerous articles and book chapters on contemporary Armenian politics and the South Caucasus. His new book is *The Armenians: From Kings and Priests to Merchants and Commissars*.

Peter J. Schraeder is professor of political science at Loyola University, Chicago, where he is a specialist of African politics and international relations. He was recently a Fulbright scholar in Tunisia (2002–3), spent 2003–5 teaching in Rome, and is the author or editor of nine books, including *African Politics and Society: A Mosaic in Transformation* (2004) and *Exporting Democracy: Rhetoric versus Reality* (2002). He is currently working on a book, *Beyond the ‘Big Man’: Democratization and Its Impacts on the Formulation and Implementation of African Foreign Policies*.

Ronald Grigor Suny is professor of history at the University of Michigan. He received his Ph.D. from Columbia University. His work integrates comparative politics and Russian history, with special attention to the non-Russian peoples. He is the author of hundreds of articles, as well as *The Making of the Georgian Nation* (1988), *The Revenge of the Past: Nationalism, Revolution, and the Collapse of the Soviet Union* (1993); *Looking toward Ararat: The Armenians in Modern History* (1993), and *The Soviet Experiment: Russia, the USSR, and the Successor States* (1998).
